The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is a well-written manuscript. However, the authors need to explain some of the symptom differences in the manuscript. The questions raised by the reviewers should be answered; and (3)</p>	[Y]

Format: There are 2 tables and 1 figure. A total of 33 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Elixigen was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form, Copyright License Agreement, the CARE Checklist-2016, and Written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Research Foundation of Zhejiang Health. The topic has not previously been published in the WJCC. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found no "Core Tip" section. Please provide the Core Tip; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation"
