Peer-Review Report: The topic is very interesting and important, and the study is well designed and well-written. However, the authors should take attention to the discussion. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 34 references are cited, including 7 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B, Grade B, Grade B, Grade B, and Grade C. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form, and the Institutional Review Board Approval Form. Written informed consent was waived. The Copyright License Agreement is not completely. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China (General Program) and Guangzhou Science and Technology Foundation. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure
