The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is a well written, well designed study and showed some interesting data. The clinical application is still questionable, but the area is new and evolving. This method could be complementary to our</p>	[Y]

current tissue studies. There are some unsettled/undressed the problems for this study. "Introduction" and "Discussion" of the manuscript is too long. Methodology section should be crisp and focus only on how the study and experiments were designed and done. There is a need of language sanitation of the manuscript by a native speaker. The questions raised by the reviewers should be answered; and (3) Format: There are 8 figures. A total of 48 references are cited, including 20 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. The study does not involve animals. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Research Fund of Seoul St. Mary's Hospital. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or
