2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: This is a case report of the gastrointestinal tract injuries after thermal ablative therapies for hepatocellular carcinoma. The topic is within the scope of the WJG.</p>	[Y]

(1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: This case report showed us an uncommon yet severe complication, thermal damage with GIT injury, and reviewed many associated articles. And it is noted that the manuscript needs careful editing by someone with expertise in technical English editing paying particular attention to English grammar, spelling, and sentence structure so that the goals and results of the study are clear to the reader. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 5 figures. A total of 59 references are cited, including 11 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A and Grade A. A language editing certificate issued by STUDIO DE NOVO was provided.

3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG.

5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can

	<p>be reprocessed by the editor; (3) I have changed manuscript type “minireview” to “case report”. The authors need to re-write the “Case Presentation” section, and add “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” section to the main text, according to the Guidelines and Requirements for case report, and provide informed consent and fill out CARE checklist form with page numbers; and (4) the authors need to provide an editable manuscript (format: .doc or .docx). 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
