The topic is within the scope of the WJSC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors reported a very interesting review paper to summarize the current tracking methods for MSC-based cancer therapies.</p>	[Y]

However, the authors need to add one more combined image to illustrate the MSC after labeling. The questions raised by the reviewer should be answered; and (3) Format: There is 1 table and 2 figures. A total of 104 references are cited, including 15 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by enago was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by National Research Foundation of Korea. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) The references' number and the square bracket totally should be
