The topic is within the scope of the WJSC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The manuscript is very well written, clear and easy to understand. However, the authors need to incorporate some tables. The questions raised by the reviewers should be answered; and (3) Format: There is 1 figure. A total of 95 references are cited,</p>	[Y]

including 16 references published in the last 3 years. There are 4 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 3 national grants. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
