The topic is within the scope of the WJSC. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: The authors reported an excellent and extensive review of a highly significant topic. However, some typo should be revised, some references should be added. The questions raised by the reviewer should be answered; and (3) Format: There is</p>	[Y]

1 table and 1 figure. A total of 179 references are cited, including 65 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Spanish Ministerio de Economía y competitividad, and Predoctoral Program in Biomedicine from the University of Cantabria and the Instituto de Investigación Valdecilla (IDIVAL). The topic has not previously been published in the WJSC.
