The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This study has been very well designed, well done for the study. method was already used in some centers. Treatment method is a little difficult to understand just by reading from (1) to (8) and the figures. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. A total of 26 references are cited, including 14 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the signed Copyright License Agreement. The authors need to provide the Biostatistics Review Certificate, the Institutional Review Board Approval Form, Institutional Animal Care and Use Committee Approval Form, The ARRIVE guidelines, and complete the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Young and Middle-aged Mainstay Talent Training Program of Fujian Provincial Health System, China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all
