Summary of the Peer-Review Report: The manuscript has useful information for readers who are interested in this field, provided a new treatment scheme, which is of interest. However, CASE SUMMARY should be written in descriptive narratives in the logic flow. CONCLUSION is too vague. The authors should write specifics in the case. the authors need to elaborate more on diagnostics and treatment to vague. Clinical data should be shown rather in Tables than in the verbalized text; and (3) Format: There are 3 figures. A total of 8 references are cited, no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade A. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. (2) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME
