Figure 3 legends are pasted twice. Suggest Figure 3 could be rearranged for more clarity; and (3) Format: There is 1 table and 3 figures. A total of 21 references are cited, no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form, Copyright License Agreement and Informed consent statement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. Without financial support. 5 Issues raised: (1) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (2) All figures, and tables should not be in the main text. They should be put at the end of this paper. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
