The topic is within the scope of the WJC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The manuscript by Lin et al is an excellently</p>	[Y]

written one. Although the results were negative for association between psychological stress and long-term blood pressure variation, it will contribute to the literature by publishing this manuscript; and (3) Format: There are 2 tables and 1 figure. A total of 15 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. No academic misconduct was found in the CrossCheck detection and Bing search. The highest single-source similarity index in the CrossCheck report showed to be 11%. The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Hualien Armed Forces General Hospital. The topic has not previously been published in the WJC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents.
