2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the carcinoma arising from anal fistula. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The manuscript is well written and very interesting because it provides useful information with MRI findings about anal carcinoma arising from anal fistula, resulting in faster times for diagnosis and treatment and consequently better prognosis for patients. small, as the authors declared, and this could be a great limitation for the scientific value of the research. The statistical research is poor. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 5 figures. A total of 20 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by ELIXIGEN was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I have changed the manuscript type “case report” to “retrospective study”, the authors need to revise the manuscript according to the Guidelines and Requirements for “retrospective study”. The authors need to provide the Biostatistics Review Certificate and the Institutional Review Board Approval Form; (2) I found no “Author contribution” section. Please provide the author contributions; (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor;

	<p>(4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Clinical Cases.</p>
