The topic is within the scope of the WJG. (1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: Very interesting paper and very well written. However, there are some issues should be addressed. Patient numbers are too small to define outcomes in</p>	[Y]

patients treated with 2 vs 20 cc of alcohol. The very short follow-up (1 and 4 weeks) makes the reviewer question CPN efficacy. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 1 figure. A total of 28 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade C. A language editing certificate issued by Bioscience Editing Solutions was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C.
