The topic is within the scope of the WJG. (1) Classification: Grade C; (2)</p> <p><b>Summary of the Peer-Review Report:</b> In this study, the authors hypothesized that RBBP4 dysregulation could play a role in colon cancer malignant progression via regulating Wnt/<math>\beta</math>-catenin pathway. The authors started the experiment by testing in colon</p>	[Y]

cancer cell lines and found that RBBP4 was highly expressed in colon cancer cell lines. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 42 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by NHC Key Laboratory of Combined Multi-Organ Transplantation, grants from Zhejiang Provincial Natural Science Foundation of China. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list.
