The topic is within the scope of the WJGS. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This paper is written smoothly with clear thinking and detailed experimental methods. grouping and statistics, there are several mistakes and typos and should be edited and revised. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 4 figures. A total of 33 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 30% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Joint Funds of the National Natural Science Foundation of China, the Natural Science Youth Foundation of Jiangxi Province, and the Foundation for Fostering Young Scholar of Nanchang University. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The language classification is Grade C. The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report and the full text of the manuscript, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions. I have sent the manuscript to the author(s) for its revision according to the Peer-Review Report and the Criteria for Manuscript Revision by Authors.
