flaws and language errors. The questions raised by the reviewer should be answered; and (3) Format: There are 4 tables. A total of 27 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by Edanz's editing services was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the Written informed consent. The STROBE Statement lacks of the page number. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 1 National grant and 4 Provincial grants. The topic has not previously been published in the WJD. 5 Issues raised: (1) The language classification is Grade C.
