provide newer dimensions in managing these complicated cerebral aneurysms; and (3) Format: There are 1 table and 2 figures. A total of 17 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form. The signed Copyright License Agreement, and the Institutional Review Board Approval Form were not provided. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. This article has been posted at Research Square as preprint article. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Tianjin Science and Technology Projects in Key Areas of Traditional Chinese Medicine. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The Institutional Review Board Approval Form were not provided. Please provide it; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of

	<p>the references. Please revise throughout; (5) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Clinical Cases, and the manuscript is conditionally accepted.
