The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B, Grade C, Grade C and Grade C; (2) Summary of the Peer-Review Report: Overall, this manuscript is well written. several problems that should be considered. The validation of the findings in another cohort might be needed. The is not a randomized study, the reasons why endoscopies were performed or not performed in these patients were unknown. The reasons why patients underwent endoscopies had better outcomes were not analyzed and discussed. The study has several limitations as outlined by the authors in the manuscript. Critical information is lacking to help the correct interpretation of the findings. For example, it is not clear why 32% of patients did not undergo GI. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 25 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A, Grade A, Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 8%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been
