sufficiently high level, statistical methods of processing the analysis results were used, the patients of both groups are identical in demographic indicators and indicators of the severity of the disease. The authors should report for both group A and group B -how many patients were initially considered for inclusion. Despite the large number of patients in the main and control groups, the study is retrospective and not randomized, which reduces the level of evidence of the study results. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 41 references are cited, including 1 reference published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A and Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Medical science and technology project of Henan Province. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
