The topic is within the scope of the WJCC. (1) Classification: Grade B, Grade B and Grade B; (2) Summary of the Peer-Review Report: The</p>	[Y]

case study is very detailed, thoroughly documented. The descriptive style the authors chose was very original and captivating. However, minor editing is required in lines 23-24 "leading to hemodialysis" should be clarified; lines 18-21 should be explained as the meaning is ambiguous; and (3) Format: There is 1 table and 8 figures. A total of 17 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Crimson was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 18 words. The title should be no more than 18 words; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Not-required. 7 Recommendation: Conditionally accepted.
