The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors gave a clear description of the case and made a fair review of the topic. Reviewer suggest incorporate and explain the difference between paraganglioma and pheochromocytoma, both</p>	[Y]

originate from chromaffin cells. In discussion, author described that in 2017, the updated WHO classification of endocrine tumors replaced the term “malignant paraganglioma” with “metastatic paraganglioma”, Please clarify the “benign”, “malignant”, and “metastatic” confusion, the concept is so confused to the readers; and (3) Format: There is 1 table and 6 figures. A total of 8 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. Without financial support. 5 Issues raised: (1) I found no “Author contribution” section. Please provide the author contributions; (2) Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
