Summary of the Peer-Review Report: The authors investigated the distribution of CD155 expression and their relationship with PD-L1 and phenotypes of exhausted CD4+ and CD8+ effector TILs to illustrate the effect of CD155 expression on immune microenvironment of breast cancer patients. Overall, this study is well designed and the manuscript is well written. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 31 references are cited, including 4 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Two Grades B. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form, and written informed consent.
