The topic is within the scope of the WJG. (1) Classification: Grade A, Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: This is an interesting manuscript describing a novel technique to achieve endoscopic drainage of WON cavities in the pancreas. report will contribute to the development of endoscopic treatment. However, there are some issues should be addressed. Author should discuss about advantage of this technique. The authors need to add more details in the “method” section. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 22 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B, Grade B and Grade C. A language editing certificate issued by BioMed Proofreading was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and Written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C. I have seen the manuscript but I couldn't find the figures in the manuscript. Legends are written in the manuscript but figures are not there. Please let me know whether the manuscript is without figures."
