detect expression of EHF. More detailed molecular mechanisms should be investigated. English should be revised. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 46 references are cited, including 5 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. No animals are involved in the study. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Traditional Chinese Medicine Science and Technology Plan of Zhejiang Province; and the Zhejiang Medical Science and Technology Program. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the authors did not provide the original figures. Please provide the original figure documents.
