The questions raised by the reviewer should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 19 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Clinical Trial Registration Statement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 8% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an invited manuscript. The study was supported by Akdeniz University Research Foundation.
