The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors aimed to evaluate the long-term outcomes of intravitreal conbercept injection with laser photocoagulation as a treatment for Coats disease in adults and</p>	[Y]

demonstrated that Intravitreal injection of conbercept combined with 532-nm laser photocoagulation may be a feasible treatment for Coats disease in adult patients. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 2 figures. A total of 31 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Shenzhen Municipal Health and Family Planning System Research Project. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the
