Grade C; (2) Summary of the Peer-Review Report: This is a potentially interesting report. However, the authors need to discuss from their data in discussion, not only repeat the results and/or results from other manuscripts in references. The miss-typing of the size of fonts should be consistent. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 6 figures. A total of 29 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Animal Care and Use Committee Approval Form or Document, and the Institutional Review Board Approval Form. The ARRIVE Guidelines is not right. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 6% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China and Sichuan Outstanding Youth Fund Project Grant. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2)
