(1) Classification: Grade A, Grade C and Grade D; (2) Summary of the Peer-Review Report: This is an interesting survey of PICUs in the US and their responses</p>	[Y]

to the COVID-19 pandemic. The data of this manuscript are very interesting and can help the scientific groups in COVID-19 related issues. Spelling mistakes and grammatical error throughout the paper, it needs comprehensive revision. Technical support to the studies was not strong enough. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables. A total of 20 references are cited, including 13 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A and Grade C. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the Institutional Review Board Approval Form. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCCM. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (2) I have changed the manuscript type "Clinical and Translational Research" to "retrospective study". The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and informed consent. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
