2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a clinical trials study of the EUS-FNB of pancreatic lesions. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The study is interesting, and the manuscript is well written. However, there are some issues should be addressed. The study design mentioned the inclusion</p>	[Y]

criteria for pancreatic solid lesion only, but in the Table 2, cystic lesions (SCN, MCN) were included into final analysis. Perhaps should consider excluding the cystic lesions. The authors need to add more details in the “method” section. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 31 references are cited, including 21 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, informed consent, CONSORT checklist form. The authors need to provide the Clinical Trial Registration Statement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (3) the author should number the references in Arabic

	<p>numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
