The topic is within the scope of the WJT. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: An interesting review on the topic of pregnancy and liver transplantation. To increase its value, the reviewer recommends a more detailed analysis regarding etiology of liver</p>	[Y]

disease and possible complications during pregnancy. Furthermore, a comparison with the outcomes of pregnancy in solid organ transplantation in general would help the reader to understand what is peculiar of liver patients and what is common instead to transplantation and immunosuppression. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables. A total of 67 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJT. The corresponding author has published 1 article in the BPG. 5 Issues raised: Please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted).
