The topic is within the scope of the WJGO. (1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: The authors reported an interesting paper that describes the authors' early experience of the taTME technique for rectal cancer. well written. However, the authors should provide the figures cited in the text. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables. A total of 17 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by MedE Medical Editing Group Inc. was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the Written informed consent. The Conflict-of-Interest Disclosure Form and Copyright License Agreement are not right. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 10% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The “Article Highlights” section is missing. Please

	<p>add the “Article Highlights” section at the end of the main text; and</p> <p>(5) The authors’ information should be added before the abstract, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked the comments written by the science editor. The authors did not provide original pictures. Please provide the original figure documents.
