The topic is within the scope of the WJG. (1) Classification: Grade B, Grade C and Grade E; (2) Summary of the Peer-Review Report: The reviewer# 04031726 did not give some specific comments. In generally, this is a good planned and designed study which would contribute the literature. However, there are some</p>	[Y]

issues should be addressed. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 5 figures. A total of 19 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to provide the Biostatistics Review Certificate, the Institutional Review Board Approval Form, informed consent, and fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Key Scientific and Technological Project of Henan Province. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor;

	<p>(4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) I found the authors did not write the “article highlight” section.
