2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a review of the spectrum of esophageal motility disorders in patients with liver cirrhosis. The topic is within the scope of the WJH. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The paper is simple but it is very good to think about esopagal motility in patients with hepatic disease. The language need to revise. The questions raised by the reviewers</p>	[Y]

should be answered; and (3) Format: There are no tables and figures. A total of 58 references are cited, including no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form, but the Copyright License Agreement lacks of the signature. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 8% and 7% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJH. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) Please add some figures or tables. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.

Editorial Office Director: I have checked the comments written by the science editor. I have changed the manuscript type "review" to "minireview". The authors need to add some tables or figures.
