However, the discussion should be re-written, and the conclusion should be shorten. The questions raised by the reviewer should be answered;</p>	[Y]

and (3) Format: There are 4 figures. A total of 60 references are cited, including no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the written informed consent. The CARE Checklist-2016 lacks of the page number. The Conflict-of-Interest Disclosure Form and Copyright License Agreement are not qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
