The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The manuscript is well written, and the topic is interesting and easy to understand for all the readers of WJG. However, some major criticisms should be addressed. Please add the new table(s) described the results on the</p>	[Y]

similar manuscripts that have been published to date, and add the new references and the more discussions on the published manuscripts on prospective studies, if possible. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 1 figure. A total of 26 references are cited, without references published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
