Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not add the full PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list
