(1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is an interesting, rare and well-visualized article that could be improved with some correction and supplement. It would be clearer if you could provide more</p>	[Y]

information about the methods used for patients re-examination and follow-up after the first occurrence of adenocarcinoma. The discussion part could provide some basic information about the recommended follow-up (methods, regularity) of such patients in order to prevent cancer re-occurrence. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. A total of 20 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided informed consent. The authors need to fill out the CARE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
