	<p>assess the relationship between RON and PD-L1 by a multiplex immunofluorescence staining. Authors should supply with some information and intention in this study of inhibitor MSP. You can discuss the possible correlation between autophagy activation and PD-L1 expression. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 6 figures. A total of 50 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Elixigen was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and the Institutional Review Board Approval Form. No animals are involved in the study. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Zhejiang Provincial Natural Science Foundation of China grant; National Natural Science Foundation of China grant; and the Zhejiang Major Medical Health &amp; Sciences Technology Foundation Projects. The topic has not previously been published in the WJG.
