2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a minireviews of the remote nursing training model combined with proceduralization in intensive care unit dealing with patients with COVID-19. The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade A; (2) Summary of the Peer-Review Report: The minireviws is written extensively and</p>	[Y]

simply. It is informative and will give useful information to readers. The review is very well written and the topic explored is timely relevant. The authors organized very well a sequence of available knowledge to document and share experiences in transitioning from traditional face-to-face programs to remote form combined with proceduralization nursing training mode in our daily work experiences during the COVID-19 pandemic, which has shown to be helpful for nurses working in the ICU. However, some questions raised by the reviewers should be answered; and (3) Format: There are 2 tables. A total of 23 references are cited, including 22 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 2 National Natural Science Foundations of China. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; and (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s). 6 Re-Review: Required. 7 Recommendation:
