2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a clinical trials study of the relationship between the incidence of non-hepatic hyperammonemia and the prognosis of patients in ICU. The topic is within the scope of the WJG. (1) Classification: Grade A and two Grades B; (2) Summary of the Peer-Review Report: The authors continuously monitored changes in the levels of blood ammonia at the time of ICU admission and after ICU</p>	[Y]

admission. In addition, factors influencing the prognosis of NHH patients were analyzed. This is a very interesting study, and the manuscript is well written. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 31 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and two Grades B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form, Copyright License Agreement, and the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Young and Middle-age Innovation Science Research Fund of The Second Affiliated Hospital of Harbin Medical University. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text
