(1) Classification: Grade A; (2) Summary of the Peer-Review Report: This is an excellent case report regarding growth hormone deficiency after intracranial hemorrhage, and its replacement therapy focused on the amelioration of cognitive status. It is indeed still a controversial issue, however the authors comprehensively</p>	[Y]

and meticulously present their case, supported by solid proofs and reasonably discuss the issue; and (3) Format: There is 1 table and 2 figures. A total of 35 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by SNAS was provided. 3 Academic norms and rules: The authors provided the Informed Consent Form. Please upload the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an Unsolicited Manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. Without financial support. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) Please upload the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
