Format: There are 3 tables and 3 figures. A total of 26 references are cited, including 14 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the Written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by China Biotechnology Development Center and Chongqing Education Commission. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The reference's number should be put in the square bracket; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) The "Article Highlights" section is missing. Please add the "Article Highlights"
