the manuscript is well written. However, there are some issues should be addressed. Recent articles on recent prognostic indicators of colorectal carcinoma can be discussed in discussion. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 5 figures. A total of 29 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B, Grade B and Grade D. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade D.
