cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by JWEDIT was provided. 3 Academic norms and rules: The authors provided the written informed consent, however the informed consent of treatment was not provided. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by The Health and Family Planning Commission of Sichuan Province, Youth Innovation Project of Medical Research in Sichuan Province. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation.
