The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors found that Patients with acute arterial embolism of the extremities should be</p>	[Y]

treated carefully, especially those who have recurrent thrombosis after emergency thrombectomy. Clinicians should be aware of polycythemia vera, a rare cause of acute arterial embolism of the extremities. The combination of thrombectomy, phlebotomy and low-dose aspirin may be a suitable therapeutic regimen for these patients; and (3) Format: There is 1 table and 3 figures. A total of 10 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: GradeA. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: Please provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Akdeniz University Research Foundation. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME
