robot-assisted laparoscopic pyeloureterostomy. The introduction is well-written; the case report is easy to follow with enough details regarding the procedure. The discussion is well balanced. Graphic material is adequately complementing the text. The questions raised by the reviewers should be answered; and (3) Format: There are 7 figures. A total of 11 references are cited, including no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades A and Grade C. A language editing certificate issued by Textcheck was provided. 3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Soonchunhyang university research fund. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s).
