found in the CrossCheck detection and Bing search. 4
Supplementary comments: This is an unsolicited manuscript. The
topic has not previously been published in the WJGO. The

Issues raised: (1) I found the authors did not provide the original
figures. Please provide the original figure documents. Please
prepare and arrange the figures using PowerPoint to ensure that all
graphs or arrows or text portions can be reprocessed by the editor;
and (2) I found the authors did not write the "article highlight"
section. Please write the "article highlights" section at the end of the
main text. 6 Re-Review: Required. 7 Recommendation:
