The topic is within the scope of the WJGE. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Congratulations on the work made. However, there are some suggestions: The procedure description should be added, the authors should use %TBWL to show the balloon results and add</p>	[Y]

some graphics and images. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 22 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the Institutional Review Board Approval Form. Written informed consent was waived. Authors are required to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGE. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (4) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted). If there
