2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective cohort study of the lymph node retrieval and survival. The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: While this is a retrospective study, it raises an important issue regarding lymph node retrieval after neoadjuvant therapy, highlighting the need to</p>	[Y]

retrieve a significant number of lymph nodes, even if there are smaller numbers of identifiable and positive lymph nodes in these patients. Statistics and figures seem to be well devised; and (3) Format: There are 4 tables and 1 figure. A total of 39 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form and informed consent. The authors need to provide the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and fill out the STROBE checklist with page numbers. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 10%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Key Research and Development Plan "Research on Prevention and Control of Major Chronic Non-Communicable Diseases"; and the Medicine and Health Technology Innovation Project of Chinese Academy of Medical Sciences. The topic has not previously been published in the WJG. The corresponding author has published 5 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved
