The topic is within the scope of the WJG. reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 34 references are cited, including 12 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A. The authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by University of Ottawa Telfer School of Management Research Grant, Natural Sciences and Engineering Research Council Innovation Grant, and Northern Scientific Training Program. The topic has not previously been published in the WJG. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and
